Edenton Farmers Market Vendor Liability Waiver

This waiver must be signed annually by all vendors participating in the Edenton Farmers Market, ("Market") whether operating indoors or outdoors. The purpose of this document is to ensure mutual understanding of responsibilities and to protect both the Market and its vendors from unnecessary risk. By signing this agreement, the undersigned Vendor ("Vendor") agrees to the following terms and conditions while participating in the Edenton Farmers Market:

1. The Vendor is fully responsible and liable for any injury, illness, property damage, theft, or loss that may occur in connection with participation in the Market, whether Market building or campus.
2. The Vendor agrees to release, protect, and hold harmless the Edenton Farmers Market, its board members, officers, volunteers, employees, and representatives from all claims, demands, and/or damage arising from participation in the Market, including those caused by negligence.
3. The Vendor is responsible for maintaining a safe and clean space and/or pavilion, ensuring that all displays, tents, tables, and equipment are properly secured and clean and do not pose a hazard to others.
4. The Vendor agrees to follow all applicable federal, state, and local regulations, including but not limited to health, food handling, product labeling, fire safety, and animal control requirements.
5. The Vendor is solely responsible for ensuring that all products, artwork, photographs, music, logos, designs, written materials, packaging, signage, and other materials displayed, sold, or used by the Vendor do not violate or infringe upon the copyrights, trademarks, patents, or other intellectual-property rights of any person or business. The Edenton Farmers Market is not responsible for any claim, complaint, demand, or legal action arising from a Vendor's alleged infringement or unauthorized use of another party's intellectual property.
6. The Vendor is responsible for any damage to Market property, equipment, or other vendors' property caused by their actions and/or negligence.
7. Vendors who bring animals to the Market, including pets, must ensure that the animals do not cause safety risks, disturbances, or unsanitary conditions. Vendors are fully responsible for the behavior of their animals and for any damage or injury created by their animals.
8. Vendors' participation in the Market is at their own risk. The Edenton Farmers Market does not provide insurance coverage for Vendors, their property, or their animals.
9. The Vendor's contact information can be shared with Market patrons unless the Vendor otherwise notifies the Market.
